#### NOTIFICATION FOR APPRENTICESHIP TRAINING

Applications are invited from the ITI passed candidates in the trade mentioned herein below for one year Apprentice Training under Apprentice Act, 1961 at this Directorate.

- 2. Age: The age of the candidate should be between 18 to 25 years as on 31.05.2025.
- 3. Stipend: Monthly Stipend will be as per Apprenticeship Act, 1961 and NAPS or as amended from time to time. The Apprentice will not be eligible for any other allowances or benefits.
- 4. Duration of Training: The duration of the apprenticeship training will be one year. The apprenticeship contract will have to be executed by the selected candidate. The contract would be terminated automatically after completion of the apprenticeship training period. Shortlisted candidates have to furnish undertaking that after completion of training they cannot demand employment.
- 5. Preference will be given to the Candidates who have completed /result awaited CITS
- 6. The above notified vacancies may increase or decrease as per the requirement of office.
- 7. Candidates should be eligible with respect to age criteria and education qualification as on 31.05.2024.
- 8. Candidates selected for one year apprenticeship training shall have no claim on direct or indirect employment at this Directorate

### 9. How to apply:

Before applying against this notification, the candidates must have the following points:

- (i) The candidate must have a valid Aadhar Number, Mobile Number & Email ID. before applying for Apprenticeship Training. Candidates should register themselves on Apprenticeship portal at <a href="https://www.apprenticeshipindia.gov.in">https://www.apprenticeshipindia.gov.in</a>.
- (ii) The candidates have to take print out of registration page as applied on portal and submit it along with all self-attested certificates of educational qualification, mark sheets and certificates, Copy of Aadhar Card etc. scan and submit along with online Application on or before 25.05.2025. #### 10. Selection Process:

Selection of Apprentice Trainees shall be on the basis of Marks secured in respective ITI trade which is subject to verification of testimonials with original documents during personal interaction. If two or more candidates secure equal marks while preparing merit list, then the candidate of higher age will be considered. The list of selected candidates information shall be sent to their registered e-mail address. Contract will, be generated in respect of the selected candidates after reporting to this Directorate.

- 11. In case any information/claim made by the applicant in his/her application is found to be false, the candidature of such applicant shall be cancelled and action, as per rule will be taken against him/her.
- 12. Selected candidates will have to undergo Medical Fitness at this Directorate Dispensary at the time of joining.
- 13. The selection of Apprentices will be subject to detailed provisions of Apprentices Act, 1961/ National Apprenticeship Promotion Scheme.
- 14. Candidate who have already taken such training from any other Govt./Semi. Govt. organisation/PSU/Private shall not be considered for this training.
- 15. The decision of this Directorate will be final and binding to all candidates on all matters relating to eligibility, acceptance or rejection of the applications, mode of selection, cancellation of the selection process, etc. No correspondence will be entertained in this regard. Filling up of the seats is solely at the discretion of this Directorate based on the suitability of candidates and no claim will arise for engagement
